Writ Petition filed under Article 226 of the Constitution of India to issue a Writ of certiorari calling for the records of the 2nd respondent dated 5.6.2015 in Letter No.B3/5090/ 2015 with respect to the aggregate demand of Rs.97,70,000/- (Rupees Ninety Seven lakhs and Seventy thousand only) towards security deposit for the building as contained in the column (v) of the impugned order of the 2nd respondent with respect to the building to be put up at proposed constructions of group development of 12 blocks of stilt Floor + 4 Floors residential building with 352 dwelling units and Creche and Health Care in Block B at S.No.461/5 of Puzhal Village Ambattur Redhills Road Chennai by quashing the same and consequently direct the 2nd respondent to grant planning permission as sought for in respect of constructions to be put up in the aforesaid property without insisting upon the demand of security deposit for development as contained in Letter No.B3/5090/2015, dated 05.06.2015 issued by the 2nd respondent.
