The petitioners, who are the defendants 2 and 4 in O.S.No.13 of 2001 on the file of the Principal District Munsif Court, Alandur have come forward with this transfer petition to transfer the same to the file of the 17th Additional City Civil Court, Chennai to be tried along with O.S.NO.14044 of 2010.

2.At the time of argument, the learned counsel for the petitioners/defendants 2 and 4 submitted that instead of transferring the suit in O.S.No.13 of 2001 pending on the Principal District Munsif Court, Alandur to the file of the 17th Additional City Civil Court, Chennai, a direction may be issued for earlier disposal of the suit in O.S.No.14044 of 2010 since it was posted for argument.

No costs. Consequently, connected Miscellaneous Petition is closed.
