The Co-operative Tribunal shall entertain the appeal without insisting on the limitation.

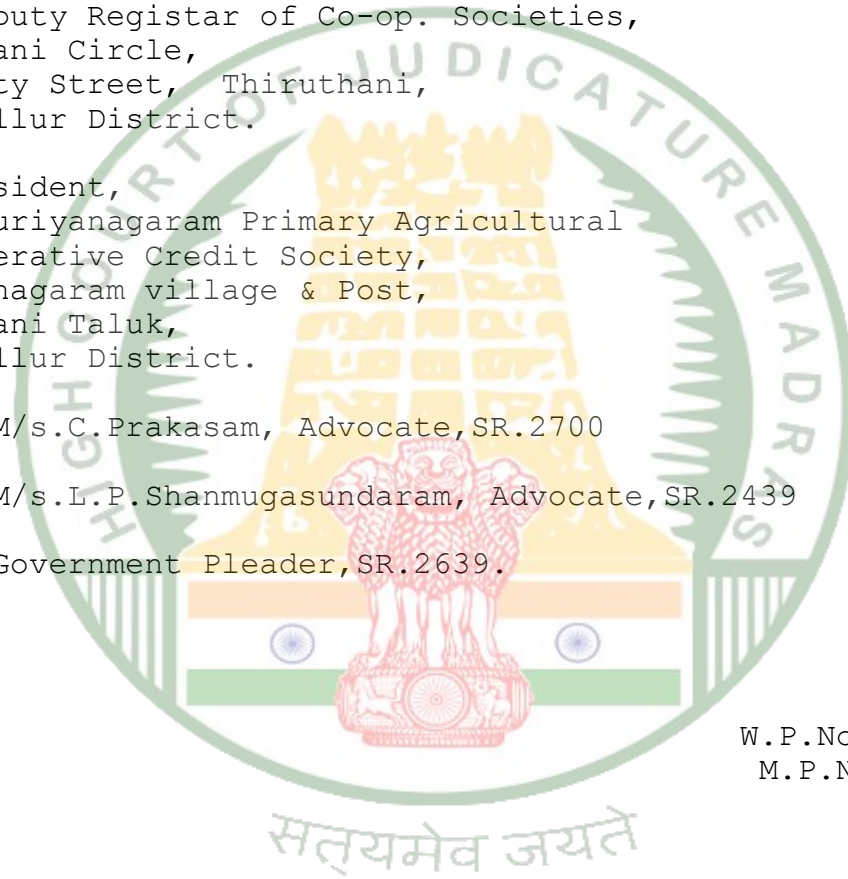
