2. With consent of both parties, the writ petition is taken up for final disposal at the admission stage itself.

3. The prayer in the writ petition lies in a narrow compass. The petitioners have registered their names in the 3rd respondent Employment Exchange for the post of Cook. They made representation dated 02.02.2015 to the first respondent to fill up the vacancies to the post of Cooks in the Adi-Dravidar and Scheduled Tribes Hostels for School Students.

4. Learned counsel for the petitioners has sought for a direction to the first respondent to pass orders on the representation of the petitioners, on merits and in accordance with law, within a stipulated time.

5. In view of the narrow prayer made, the first respondent is directed to pass orders on the representation of the petitioners dated 02.02.2015, on merits and in accordance with law, within a period of eight weeks from the date of receipt of a copy of this order. Accordingly, the writ petition is disposed of. No costs.
