Such exercise shall be completed within a period of three months from the date of receipt of a copy of this order.

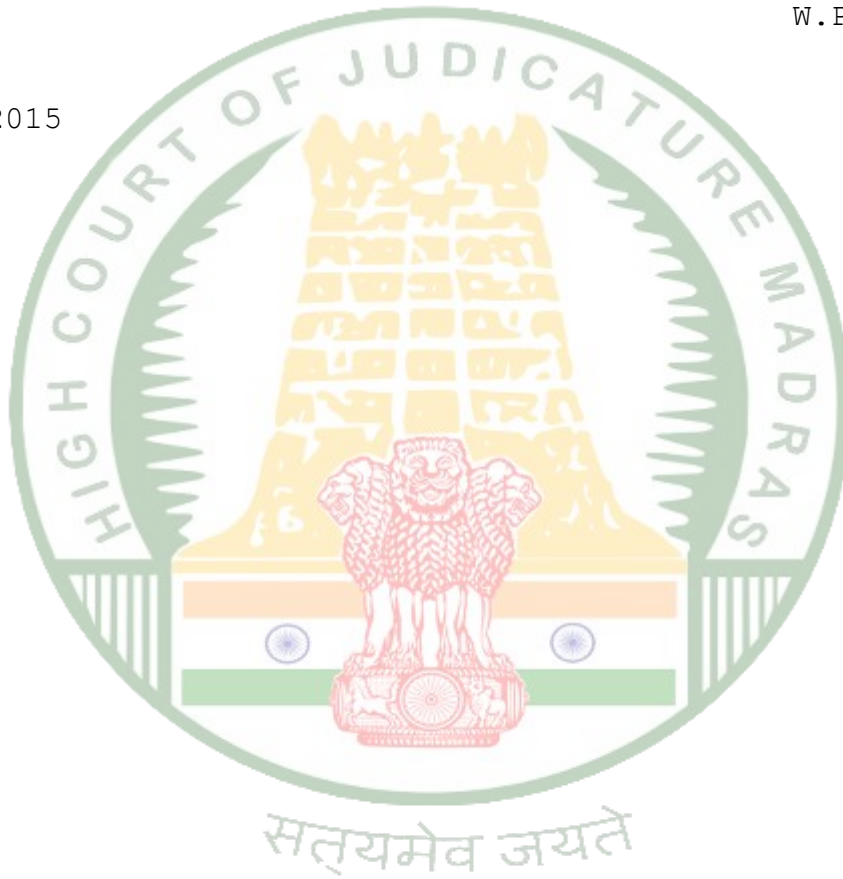
