Petition under Article 226 of the Constitution of India, praying for issuance of a writ of mandamus, directing the second respondent to consider the last date of examination for the departmental test which is 23.12.2006 as the date for consideration of eligibility instead of the date of the publication of the result which is 16.03.2007 and accordingly include the name of the petitioner in the panel for promotion to the post of Assistant in the year 2007-2008 and consequently direct the second respondent to correct the seniority list prepared for promotion in the post of Superintendent in proceedings in Na.Ka.No.23254/A3/E1/2014, dated 28.11.2014, by placing the petitioner in the appropriate place in the post of Assistant in the year 2007-2008.

The petitioner was appointed as a Junior Assistant and later he was promoted as an Assistant. The grievance of the petitioner is that the last date of examination for departmental test has to be taken into consideration instead of the publication of the result of the departmental test for inclusion of the name of the petitioner in the panel for promotion to the post of Assistant for the year 2007-2008.
