JUDGMENT

(Judgment of the Court was delivered by The Hon'ble Chief Justice)

The election has already been held. The order passed for conduct of election is subject to the result of the suit. There is also a direction that the pleadings should be completed by a specific date of 15.09.2015 and it is the case of the appellant that those pleadings have not been filed.

2. In our view, this is not a case for interference and if the respondents have not taken steps to file the pleadings, the matter can be taken on the undefended board for necessary directions.

3. The appeal is dismissed with the aforesaid observation. No costs.
