Prayer in W.P.No.34911/2014: This Writ Petition is filed under Article 226 of the Constitution of India, seeking for a writ of declaration, declaring the Land Acquisition proceedings initiated under Sec.4 (1) of the Land Acquisition Act 1894 in respect of the lands comprised Survey No.21 measuring an extent of 2.08 Acres and in Survey No. 475 measuring an extent of 2.60 Acres situated at Vellakinaru Village Coimbatore (North) Taluk Coimbatore District deemed to have lapsed in view of Sec. 24 (2) of the Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation and Resettlement Act 2013 (Act 30/2013) and consequently direct the respondents to re-assign/re-allot the lands with power of alienation comprised Survey No.17 measuring an extent of 2.08 Acres and in Survey No. 475 measuring an extent of 2.60 Acres, situated at Vellaikinaru Village, Coimbatore (North) Taluk, Coimbatore District in favour of the Petitioner.
