ORDER

In view of the limited prayer made in the Writ Petition, by consent, the Writ Petition itself is taken up for final disposal.

2. The petitioner worked as a Part-time Maniam at No.23, Pudur, Malaiyamedu, from 14.07.1976 to 19.02.1978 before the post was abolished by the Government in 1980. Thereafter, he was appointed as a Village Administrative Officer on 28.10.2005. He retired from service on 31.05.2010. He claims minimum pension as per

G.O.Ms.No.158, Revenue Department, dated 08.04.2015. He made a representation dated 27.06.2015 in this regard.

3. In the aforesaid facts and circumstances of the case, a direction is issued to the 1<sup>st</sup> respondent to pass appropriate orders on the representation of the petitioner dated 27.06.2015 in the light of the G.O.Ms.No.158, Revenue Department, dated 08.04.2015, for minimum pension, within a period of twelve weeks from the date of receipt of a copy of this Order.

4. With the above observation, the Writ Petition is disposed of. No costs.
