2. The petitioner is working as a Secondary Grade Teacher in the

It is the case of the petitioner that a vacancy arose in B.T. Assistant (Tamil) in the 4th respondent's School. The petitioner made a representations dated 25.09.2013 and 15.10.2013 to the respondents to consider her promotion to the post of B.T. Assistant (Tamil). Now the petitioner seeks for a direction to the 4th respondent to pass orders on the representations dated 25.09.2013 and 15.10.2013 on merits and in accordance with law.

3. In view of the narrow prayer made, a direction is issued to the 4th respondent to consider the petitioner's representations dated 25.09.2013 and 15.10.2013 and pass orders on merits and in accordance with law within a period of eight weeks from the date of receipt of a copy of this order.

This Writ Petition is disposed of accordingly. No costs.
