The petitioner is working as an Assistant Elementary Educational Officer. While so, he participated in the selection for the post of PG Assistant, Tamil, and he was selected, but, not relieved to join the post of PG Assistant, Tamil, as a disciplinary proceeding is pending against him, pursuant to the charge memo, dated 06.08.2014, issued by the second respondent. Hence, the petitioner has come before this Court by way of this Writ Petition.

2. Considering the facts and circumstances of the case, the second respondent is directed to conclude and pass final orders on the disciplinary proceedings, relating to the charge memo issued by him against the petitioner in Na.Ka.No.015042/14/2014, dated 06.08.2014, within a period of three months from the date of receipt of a copy of this order and till the passing of final orders by the second respondent on the disciplinary proceedings, the third respondent is directed to keep one post of PG Assistant, Tamil, vacant.

3. Writ Petition is disposed of accordingly. No costs. Consequently, the connected M.P.No.1 of 2015 is closed.
