2. The petitioner has come up with this writ petition, seeking for a direction to respondents 1 and 2 to regularise the service of the petitioner in the cadre of Junior Assistant, based on the proposal sent by the third respondent in Na.Ka.No.196/A1/2013 dated 14.02.2013.

In view of the narrow prayer made, the writ petition is disposed of by directing respondents 1 and 2 to pass orders on the proposal of the third respondent dated 14.02.2013, relating to regularisation of service of the petitioner, within a period of twelve weeks from the date of receipt of a copy of this order.
