O R D E R

The petitioner was appointed as Lecturer in Physics by the third respondent. The appointment was made on 13.07.1998. The appointment was approved by order dated 03.01.2000 by the first respondent. However, she was not given the benefit of earlier service from 13.07.1998 to 02.08.1999. The petitioner submitted a

representation on 28.11.2014 requesting the first respondent to regularise the said period. The petitioner in the said representation submitted that the appointment was made against a sanctioned vacancy. The representation is now pending on the file of the first respondent.

2. The first respondent is directed to consider and dispose of the representation submitted by the petitioner on 28.11.2014 on merits and as per law and taking into account the fact that the appointment of the petitioner was against a sanctioned vacancy. Such exercise shall be completed within a period of three months from the date of receipt of a copy of this order.

3. The Writ petition is disposed of with the above direction. No costs.
