Prayer:- Writ Petition has been filed under Article 226 of the Constitution of India for issuance of Writ of Mandamus directing the respondents to give permission to conduct the dance programme on 16.09.2015 in the event of Sri Sakthi Muthumariamman Thirukoil of Madhikonpalayam, Dharmapuri District.

O R D E R

By consent, the writ petition is take up for final disposal.

2. The petitioner claims to be the Dharmakarthha of Sri Sakthi Muthumariamman Thirukoil of Madhikonpalayam, Dharmapuri District. He would state that village people have decided to conduct Sri Sakthi Muthumariamman Thirukoil Thiruvilla on 16.09.2015 in a grand manner. The petitioner submitted a representation dated 24.07.2015, to the second respondent seeking permission to conduct village folk dance and other cultural programmes on 16.09.2015 at the said temple and since no orders came to be passed, he filed this writ petition.

3. Heard the submissions of Mr.T.Pappaiah Dharmarajan, learned counsel appearing for the petitioner. The learned counsel for the petitioner would submit that the programme will be conducted in a peaceful manner without creating any law and order problem and they

will not perform any obscene dance or any obscenity in the song and dance programme. The learned counsel hence prays for appropriate orders.

4. This Court heard the submission of Mr.V.Subbiah, learned Special Government Pleader who accepts notice for the respondents.

5. This Court taking into consideration the limited scope of the prayer made in this writ petition, directs the second respondent to consider and dispose of the representation of the petitioner dated 24.07.2015, on merits and in accordance with law and pass orders on or before 11.09.2015 and inform the decision taken to the petitioner. The writ petition is disposed of accordingly. No costs.
