Ltd., registered under Document No.1689/04, dated 6.5.2004 and Document No.5848/2004 dated 16.12.2004 at the office of the Sub-Registrar, Thiruporur and direct the respondents 1 and 2 to resume possession of the properties forming part of the above said two sale deeds dated 6.5.2004 and 16.12.2004 and (ii) WP.8478/2006 - Writ of Mandamus to direct the 5th respondent to conduct an impartial investigation into the sale of 103.1 acres of SIPCOT land at Siruseri in favour of the 3rd and 4th respondents by the 1st and 2nd respondents and to file a report before this Court.

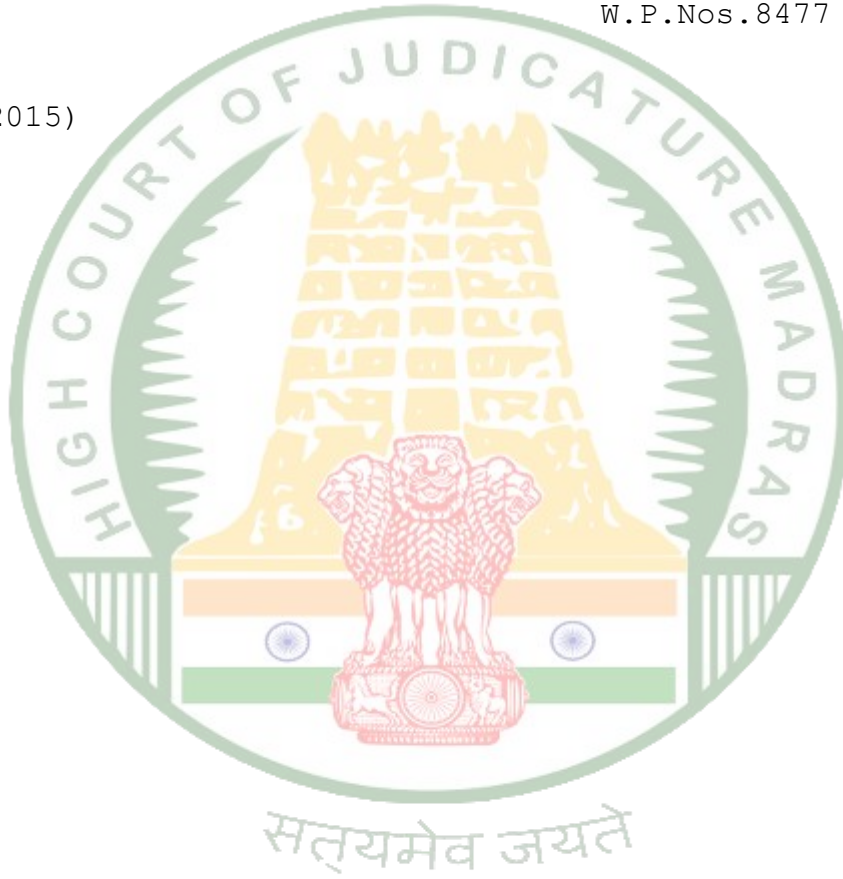
