The Presiding Officer, Family Court, Puducherry is directed to

dispose of both the cases viz., H.M.O.P.No.79 of 2014 and M.O.P.No.122 of 2014 jointly within six months from the date of receipt of the material papers.

5.Accordingly, this Transfer Civil Miscellaneous Petition is ordered. No costs.
