ORDER

The learned Special Government Pleader appearing for the fifth respondent submitted that the fifth respondent is not interfering with the running of the petitioner-club so long as activities are legal. He further submitted that, if any illegal activities are being carried, the fifth respondent may be given permission to take action.

3. In view of the above submission, the writ petition is disposed of with a direction to the fifth respondent not to interfere with the legal activities of the petitioner. It is made clear that in the event of any illegal and unlawful activities are carried out, it is open to the respondents to take appropriate action. No costs. Consequently, connected miscellaneous petition is closed.

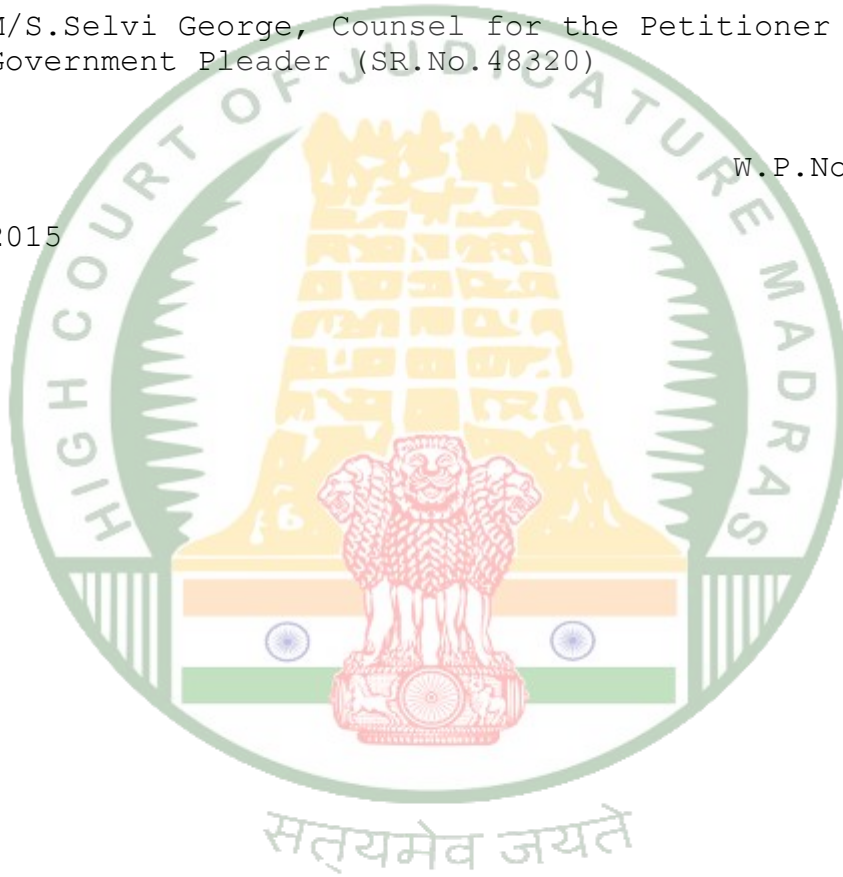
