We are informed that the petitioners have failed to obtain the requisite marks in the written test. The second aspect raised in these petitions pertains to the benefit that the petitioners claim on having studied in Tamil Medium at school level, which aspect is covered by our order in W.P.No.27005 of 2015 (between D.Anbarasu vs. The Secretary to Govt., Home (Police) Dept.), decided on 08.09.2015 and only if the petitioners have ultimately qualified, would the occasion of preference have arisen.

2.Writ Petitions are, thus, dismissed. No costs. Consequently, M.P.Nos.1 and 2 of 2015 are also dismissed.
