The only impediment in the way of the petitioner while seeking to get recruited as Sub Inspector in pursuance to the notification dated 08.02.2015 was the inadequate height during the Physical Endurance Test. This height was re-verified and the petitioner was found eligible and permitted to go to the next stage of Viva Voce.

2.Thus, the petitioner is entitled to the declaration of his results on merit.

3.Writ petition, accordingly, stands allowed. No costs.

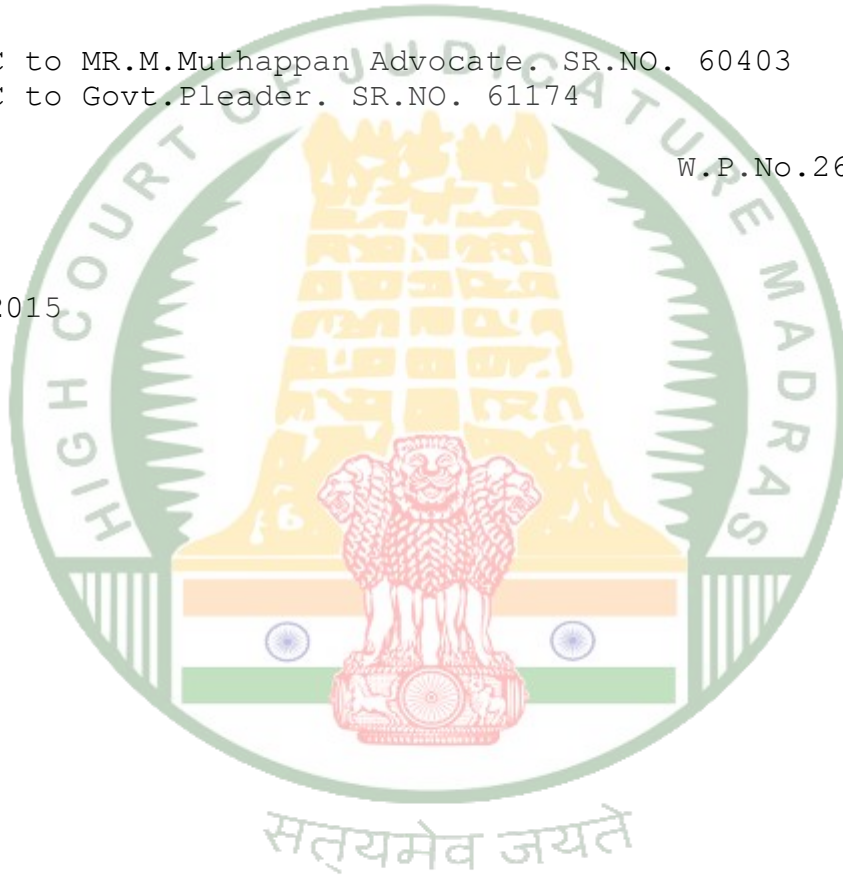
