Considering the nature of the prayer sought for and taking note of the fact that the petitioners are prepared to surrender before the learned Principal District and Sessions Judge, Krishnagiri, Krishnagiri District, there shall be a direction to the learned Principal District and Sessions Judge, Krishnagiri, Krishnagiri District, to consider the bail application to be submitted by the petitioners along with their surrender before that Court, on the same day on merits and pass appropriate orders.
