O R D E R

3. I have heard the learned counsel appearing for the petitioner and the learned Additional Public Prosecutor appearing for the respondents.

4. The learned Additional Public Prosecutor submitted that on receipt of the complaint of the petitioner, C.S.R.No.1156 of 2015 has been assigned and the matter is pending for enquiry.

5. In view of the submissions made by the petitioner as well as the Additional Public Prosecutor, this Court directs the respondents to conduct enquiry on the complaint of the petitioner dated 27.09.2015 in C.S.R.No.1156 of 2015 and proceed further in accordance with law, as early as possible.
