3.The Writ Petition is disposed of accordingly. No costs.

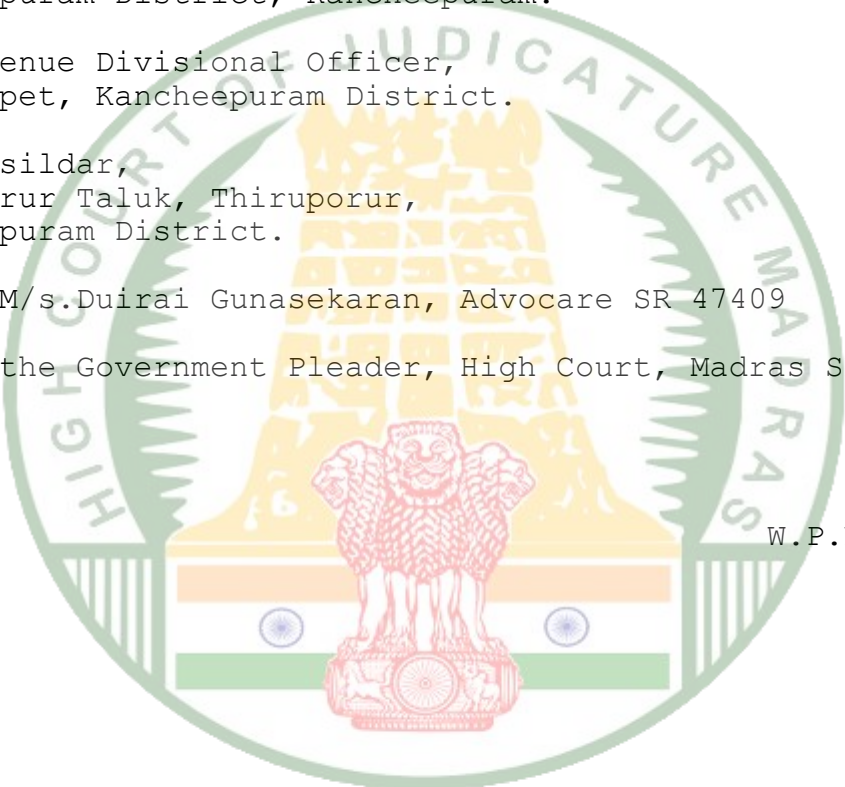
