Learned counsel for the petitioner, after some arguments, states that he is more concerned with number of hoardings which are yet to be removed and he would like to know the reason why these hoardings are not being removed, while the petitioner's hoardings have been selectively removed.

2.The aforesaid being the position, that is not encompassed in the present writ petition and the petitioner can make a representation in that behalf, which would actually be expected to be replied to within a reasonable time by the concerned authority, so that the petitioner is aware of the reasons.

3.Writ Petition stands dismissed with the aforesaid observation. No costs.
