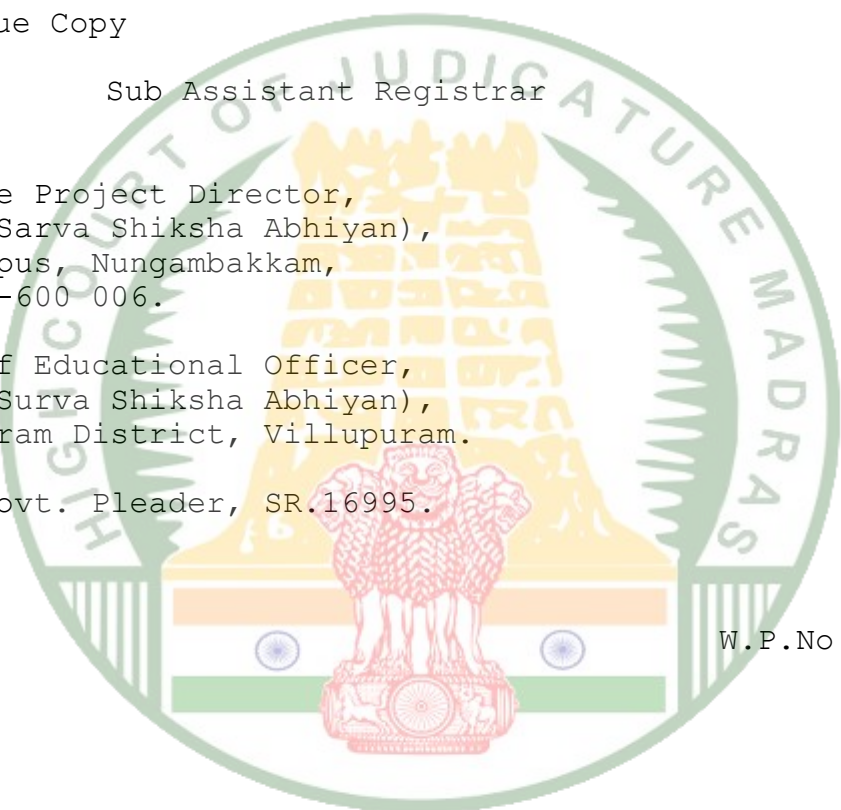

The seal of the High Court of Judicature Madras is a circular emblem.
