With consent, the writ petition is taken up for final disposal.

2. The petitioner made an application before the first respondent seeking Kurumans (ST) community certificate to his wife. The said application was turned down by the first respondent by order dated 10 July 2015. Feeling aggrieved, the petitioner has come up with the instant writ petition.

3 Today, when the matter is taken up for hearing, the learned Government Advocate appearing for the respondents fairly submits that the authorities have noticed some discrepancies and irregularities in the impugned order. Thus, the authorities be permitted to recall the impugned order and take a fresh, reasoned and conscious decision on the petitioner's application, on merits and in accordance with law, within a period of six weeks.

4. In view of the above submission made by the learned Government Advocate, according to the learned counsel for the petitioner, nothing survives for adjudication in this writ petition, at this stage.

5. Thus, recording the aforesaid submissions made by the learned counsel on either side, the writ petition stands disposed of. Costs made easy. Connected Miscellaneous Petition is closed.
