2. Heard the learned counsel appearing for the petitioner as well as the learned Additional Public Prosecutor appearing for the respondent.

Considering the nature of the prayer sought for and taking note of the fact that the petitioners are prepared to surrender before the learned Principal Sessions Judge, Salem, there shall be a direction to the learned Principal Sessions Judge, Salem, to consider the bail application to be submitted by the petitioners on the same day on their surrender before that Court, on merits and in accordance with law and pass appropriate orders.
