2.The petitioner has filed this writ petition seeking for issuance of Writ of Mandamus directing the third respondent to issue patta in respect of the house site bearing Plot No.47, comprised in Town Survey No.518/1B situate at Hosur Village and Taluk, Krishnagiri District based on the petitioner's representation dated 15.09.2014.

3.It appears that another owner approached this Court in W.P.No.19391 of 2014 and obtained an order directing the respondents to consider his representation.

4.Therefore, following the said order, the writ petition is disposed of as hereunder:

"The respondents are directed to dispose of the representation dated 15.09.2014, submitted by the petitioner on merits and in accordance with law, within a period of four weeks from the date of receipt of a copy of this order, after hearing the persons concerned. It is made clear that this Court has not gone into the merits of the case projected by the petitioner in this writ petition."
