C O M M O N O R D E R

By the impugned notice dated 07.08.2015, it was made known that in the event of any eligible beneficiaries' names having been left out, objections can be raised, which would be considered before drawing final list. The impugned notice also states that a tentative list of 299 beneficiaries is published. The petitioners made representations. Thereafter, they have come forward to file these Writ Petitions.

2.The learned counsel for the petitioners submitted that without considering the objections of the petitioners, orders are likely to be passed by drawing the final list.

3.The learned Government Advocate (Puducherry) for the respondents submitted that the petitioners' objections would be considered before publishing the final list.

4.The statement of the learned Government Advocate (Puducherry) is recorded and the Writ Petitions are disposed of by directing the respondent nos.2 & 5 to consider the objections of the petitioners before publishing the final list. No costs. Consequently, the connected miscellaneous petitions are closed.
