O R D E R

2.The learned counsel for the petitioner submitted that the pending representations dated 03.08.2015 and 18.08.2015 made to the respondent no.3 may be directed to be disposed of.

3.Taking into consideration the submission made, a direction is issued to the respondent no.3 to consider and pass appropriate orders on the pending representations of the petitioner within a period of eight weeks from the date of receipt of a copy of this order, after affording opportunity to the petitioner as well as to the private respondents.

4.The Writ Petition is disposed of accordingly. No costs.
