Prayer: Writ Petition filed under Article 226 of the Constitution of India, seeking for a writ of mandamus directing the respondents to dispose the representation of the petitioner dated 07.01.2015 to count his Higher Grade place service as Secondary Grade Assistant service from 06.07.1967 to 30.09.1970 for 3 years and 3 months for determination of his service benefits and pensionary benefits and to grant the consequential benefits arising thereof.

By consent, the writ petition is taken up for final disposal.

2. The petitioner was initially appointed as Secondary Grade Teacher and served as Higher Grade teacher from 06.07.1967 to 30.09.1970 for 3 years and 3 months in Vembakkam Panchayat Union, Tiruvannamalai District and got his promotion as Secondary Grade Assistant Teacher on 01.10.1970 and served in that capacity till 09.06.1974. The petitioner was promoted as Elementary School Headmaster on 10.06.1974 and continued in that capacity till 13.06.1976 in the said Panchayat Union. On 27.08.1983, he was transferred to Cheyyar Panchayat Union Unit and till 31.12.2000, [the age of superannuation] the petitioner continued to work in the said post of Secondary Grade Assistant. The petitioner would further submit that had he continued in the post of Elementary School Headmaster on 01.06.1988, he would have got a chance of getting Special Grade Elementary Headmaster pay from 01.06.1988 onwards. According to the petitioner, similarly placed persons have approached this Court and have obtained various orders, which have been implemented also. In this regard, the petitioner submitted a representation dated 07.01.2015 to the respondents and since no orders have been passed, he came forward to file this writ petition.

3. Heard the submissions of the learned counsel for the petitioner and Mr.S.Gunasekaran, learned Government Advocate who accepts notice on behalf of the respondents 1 to 4.

4. Though the petitioner has sought for a larger relief, this Court, in the light of the above facts and circumstances and without going into the merits of the same, directs the respondents 2 to 4 to consider and dispose of the petitioner's representation dated 07.01.2015 on merits and in accordance with law and pass orders within a period of eight weeks from the date of receipt of a copy of this order and communicate the decision taken to the petitioner.

5. The writ petition is disposed of accordingly. No costs.

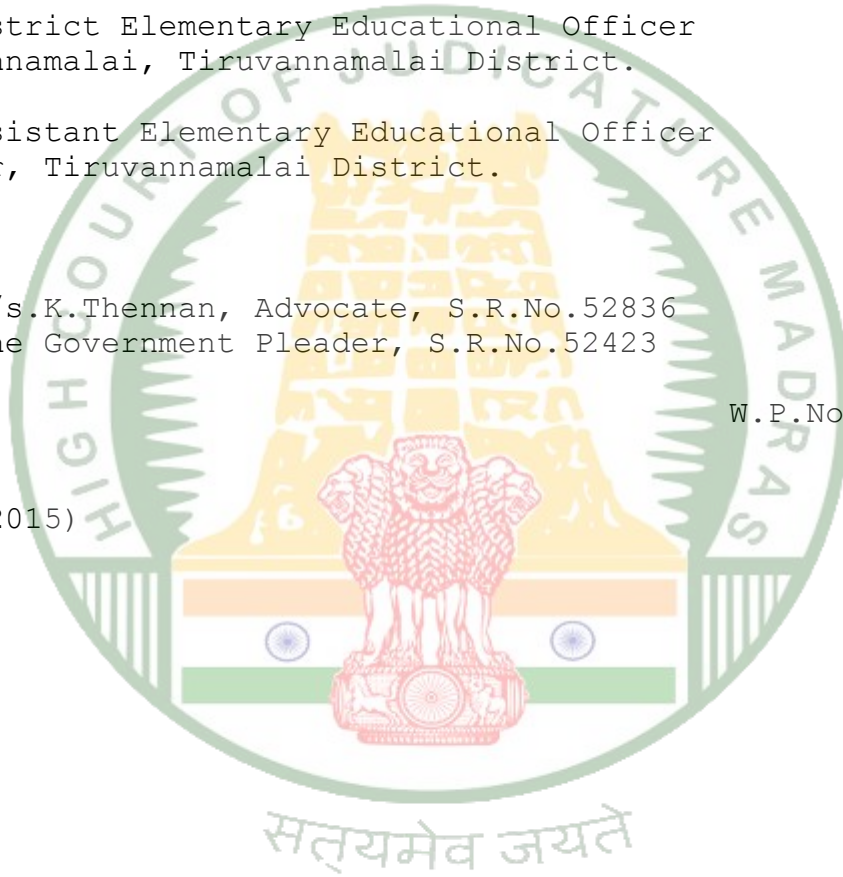
