It is seen from page No.12 of typed set of documents, annexed along with this Petition that the petitioner's representation has been considered, and the Sub Collector/Thiruvallur, viz., the second respondent has issued directions to the Tahsildar, the third respondent herein to take appropriate action in the matter, vide proceedings dated 23.10.2014, bearing Na.Ka.No.1484/2014/A2.

In the light of the same, there shall be direction to the third respondent/Tahsildar to comply with the direction issued by the second respondent, vide proceedings, dated 23.10.2014, and take appropriate action in accordance with law, within a period of three months from the date of receipt of a copy of this order.

5. With the above observations, this Writ Petition is disposed of. No costs.
