We are not inclined to entertain this petition, as the order of this Court in W.P.No.3399 of 2015 dated 19.12.2014 was assailed further in appeal before the Hon'ble Supreme Court in S.L.P.No.6231 of 2015 and admittedly, vide order dated 09.03.2015, status quo has been granted by the Hon'ble Supreme Court. Thus, the Supreme Court is in seizin of the issue, which is now sought to raise in the present Public Interest Litigation.

2.Writ petition, thus, stands dismissed. No costs. Consequently, M.P.Nos.1 and 2 of 2015 also stand dismissed.

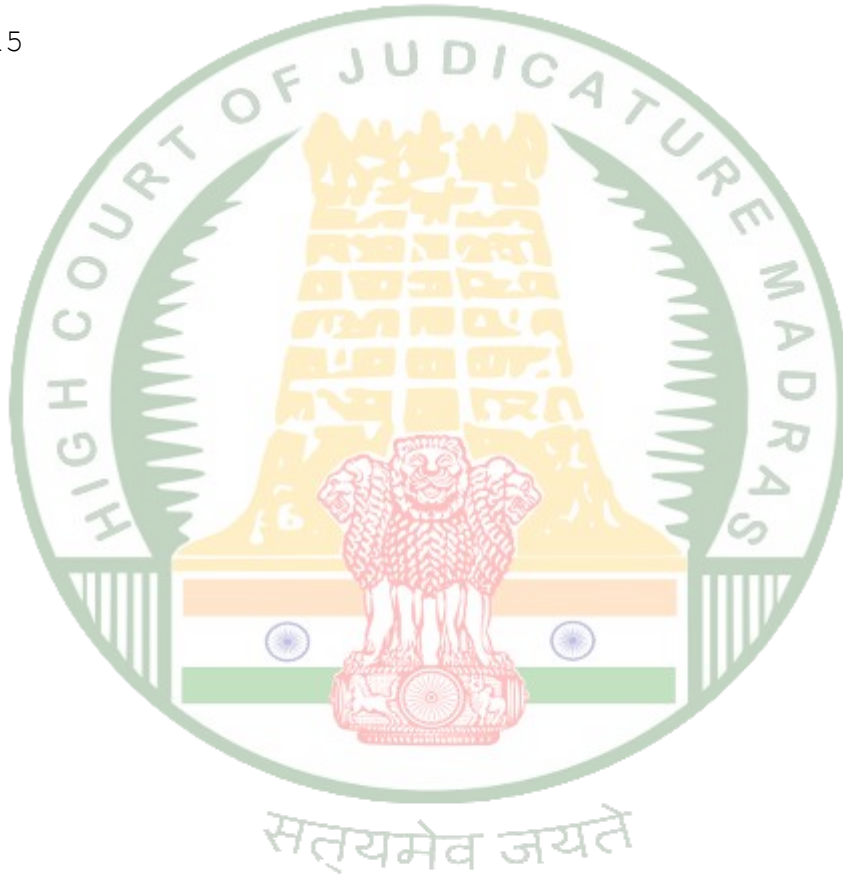
