Seeking early disposal of the same, the present Writ Petition has been filed.

2.Taking into consideration the above said facts, a direction is issued to the Revenue Divisional Officer, Ranipet to pass appropriate orders on the pending representation dated 14.05.2015, after receiving the report from the respondent no.2, after affording

opportunity to the petitioner as well as to the respondent nos.3 & 4, within a period of eight weeks from the date of receipt of a copy of this order.

3.The Writ Petition is disposed of accordingly. No costs. Consequently, the connected miscellaneous petition is closed.
