Writ Petition filed under Article 226 of the Constitution of India praying for issuance of a Writ of mandamus directing the respondents to survey and identify the property situated in Vellore District, Arakkonam Taluk, Arakkonam Sub District, No.72, Ichiputhur Village, Hamlet of Ameerpet Village in Old Gramanatham Survey No.716/1 Av. 10.04 cents and new house site S.F.No.785/11, 785/12 and 785/13, the house site measuring East to West 16 and 1/3 yard and North to South 16 1/2 yard situated to the West of Road North to South leading from Janab Street to Nadu Street, East of Vacant site of Srinivasa Chetti (Son of Kajula Sanjeevi Chetti) to the South of Tailor Palani Site and to the North of Site of Davuli Subramania Chetti) covered under registered document No.661/79 dated 16.03.1979 and thereby dispose of the petitioner's representation dated 27.05.2015.
