2. The petitioners seek for issuance of a writ of mandamus to comply and implement the order passed by the first respondent dated 21.5.2015.

3. It is not known whether the second respondent has challenged the said order by filing any appeal. According to the petitioners, no such challenge has been made and no notice has been received.

In case, the said order dated 21.5.2015, has not been challenged by the second respondent, it is always open to the petitioners to initiate appropriate action under the provisions of the Tamil Nadu Industrial Establishment Conferment of Permanent Status to Workmen Act, which will also include initiation of prosecution against the second respondent.

The Writ Petition is disposed of accordingly. No costs.

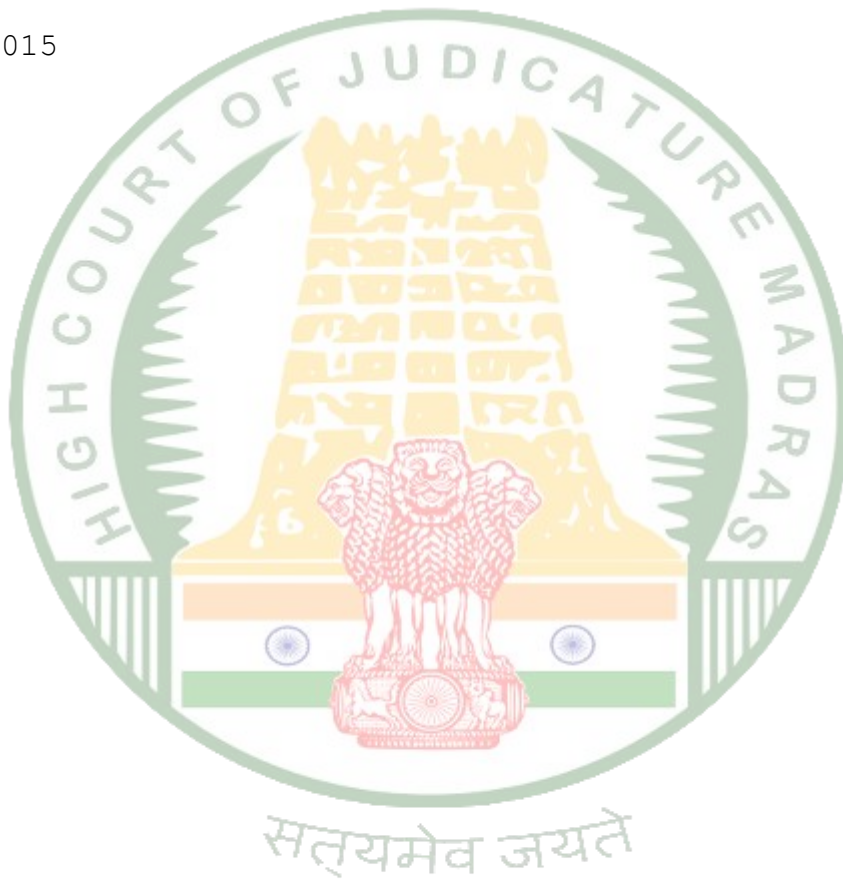
