In view of the same, this petition is closed with liberty to the petitioner to give a copy of the complaint dated 06.02.2015, to the Superintendent of Police, CID, Pondicherry and the same shall be assigned to any competent officer, who shall look into the complaint and conduct an enquiry. During the course of enquiry, if any cognizable offence is made out, action shall be taken as per the law laid down by the Honourable Apex Court in Lalita Kumari vs. Govt. of U.P. & others [2013 (4) Crimes 243 (SC)].
