4 Considering the limited scope of prayer sought for, without going into the merits of the case, a direction is issued to the first respondent to dispose of the said appeal within a period of three months from the date of receipt of a copy of this order, if it is otherwise in order. In the meanwhile, there shall be an order of status quo as of today shall be maintained.

The Writ petition stands disposed of accordingly. Consequently, connected miscellaneous petitions are closed. No costs.
