ORDER

By consent, this writ petition is taken up for final disposal.

2.The grievance of the petitioner is that his service was regularised with effect from 15.03.1976 instead of 18.09.1975. The earlier appeal filed before the respondents 2 and 3 were rejected and now the appeal is pending before the first respondent for consideration. Hence, the present writ petition before this Court.

3. Heard the submissions of Mr.T.Ranganathan learned counsel appearing for the petitioner and Mr.V.Jayaprakash Narayanan, learned Special Government Pleader, who accepts notice on behalf of the respondents.

Though the petitioner prayed for a larger relief, this Court in the light of the facts and circumstances and without going into the merits of the case, directs the first respondent to consider and dispose of the petitioner appeal petition dated 30.01.2015 and pass orders on merits and in accordance with law, within a period of sixteen weeks from the date of receipt of a copy of this order and communicate the decision taken, to the petitioner.

5. The Writ Petition is disposed of accordingly. No costs.
