COMMON ORDER

The petitioners have come forward to file the present writ petitions seeking direction to the respondent to sanction and disburse educational loan. A perusal of the records would show that an order was passed by the Bank Ombudsman on 7.10.2015 stating that the dispute with respect to the forwarding the applications cannot be considered since there are contradictory claims between the petitioners and respondent. This order has not been challenged. In

any case, the dispute, being one of fact, this Court cannot go into the same.

2. However, considering the facts and circumstances of the case, the petitioners are permitted to give a fresh application to the Bank of Baroda, Alangayam Panchayat. As and when such applications are given by the petitioners, the said authority will have to consider and take appropriate action expeditiously. The writ petitions are disposed of accordingly. No costs.
