2. The competent authority, who has to look into the grievance of the petitioner is the District Registrar (Administration), who has been newly impleaded as the 6th respondent by order dated 19.11.2015 in M.P. No. 2 of 2015.

3. Hence, the petitioner is at liberty to file a fresh application to the District Registrar (Administration) bringing out the alleged fraud said to have been committed by private respondents. As and when such an application is made, the 6th respondent will look into the same and take appropriate action in the manner known to law. The writ petition is disposed of accordingly. No costs. Connected M.P. is closed.
