As no further action is forthcoming pursuant to the same, the present writ petition has been filed by the petitioner before this Court.

2. Heard the learned counsel appearing for the petitioner and the learned Special Government Pleader appearing for the respondents.

Considering the pendency of the representation dated 27.07.2015 made by the petitioner, a direction is hereby issued to the 2nd respondent to consider and pass appropriate orders on the petitioner's representation dated 27.07.2015, within a period of eight weeks from the date of receipt of the copy of this order, after affording an opportunity of hearing to the petitioner as well as respondent No. 3. No costs.

The writ petition is disposed of accordingly. No costs.
