PETITION under Article 226 of The Constitution of India praying for the issuance of a Writ of Mandamus directing the second respondent to consider the petitioner's representation dated 30.9.2015 and further direct the second respondent to give separate patta in the name to the properties allotted to the petitioner in oral partition between the family members situated in patta Nos.593 and 783, except the properties situated in S.No.485/2 to an extent of 3 acres, half share in well situated in S.No.485/1, which was allotted to the legal heirs of the petitioner's deceased brother, who, in turn, sold to one Narasimman and Govindaraj and half share in the well situated in S.No. 485/2, which was allotted to Sri Lakshmi Narasimma Swamy temple at Sholinghur.

Therefore, the writ petition is disposed of with a direction to the second respondent to consider the representation of the petitioner dated 30.9.2015 on merits, after issuing notice to all the other joint pattadhars in patta Nos.593 and 783 and after conducting an enquiry, pass a reasoned order in accordance with law within a period of three months from the date of receipt of a copy of this order. No costs.

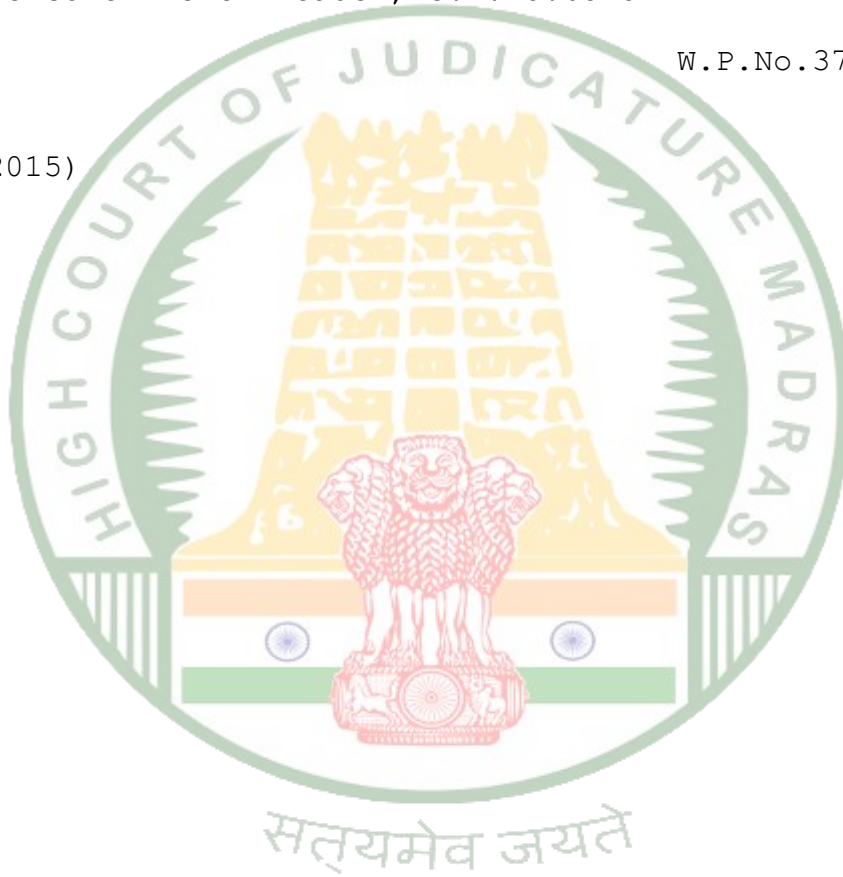
