Considering the same and without going into the merits of the case, a direction is issued to the first respondent, to pass appropriate orders on the representation of the petitioner dated 31.10.2015, on merits and in accordance with law, within a period of eight weeks, from the date of receipt of a copy of this order, after affording an opportunity of personal hearing to the petitioner as well as the fifth respondent.

4. With the above direction, the present Writ Petition is disposed of. No costs.
