ORDER

Seeking a direction to the respondent to complete the investigation and file the final report in connection with Crime No.98 of 2014 and file final report, the petitioner has come up with this petition.

2. Heard the learned counsel for the petitioner and the learned Additional Public Prosecutor appearing for the respondent police.

3.It is seen that a case in Crime No.98 of 2014 was registered under Section 174 of Cr.P.C. pursuant to the death of one Revathi. It appears that a dying declaration of Revathi was also recorded on 13.08.2014 by the learned Judicial Magistrate, Chengalpet.

4.Today, the respondent police has filed a counter wherein in paragraph 9 it is stated as follows:

"It is submitted that based on the statement of the witnesses, it reveals that the deceased has self immolated by fire and the reason for the deceased's pregnancy was not known by them, hence, on 12.03.2015, the case was referred as "Further Action Dropped" and submitted the final report before the Tahsildar, Vandavasi, Thiruvannamalai District".

5. In the facts and circumstances, this Court directs the Tahsildar, Vandavasi, Tiruvannamalai District to forward the action drop report along with all the records before the learned Judicial Magistrate, Vandavasi, who shall issue notice to the defacto complainant before accepting the closure report. However, the defacto complainant is at liberty to file protest petition on receipt of such notice. With the above observation, the Criminal Original Petition is closed.

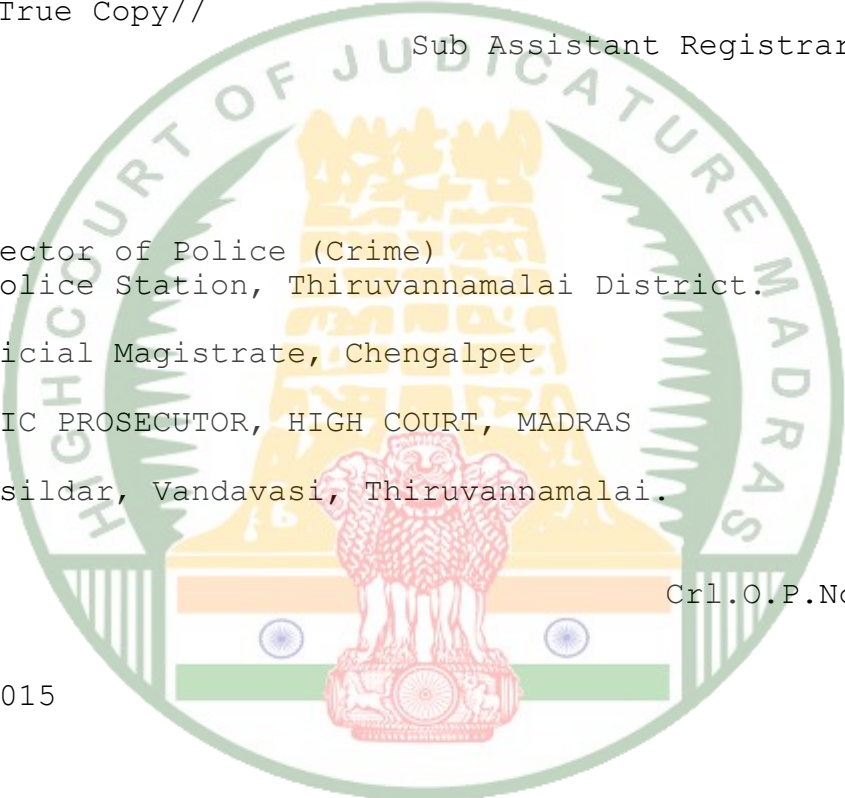
