According to the petitioner, he is the owner of the Multi Axle Goods Vehicle Taurus Tipper Lorry bearing Reg.No.TN-12- E-8934 and the same was parked at the trucker terminal containing sand loaded from Government authorized quarry and on 25.02.2015 at about 7 p.m, the same was seized by the 2nd respondent and had not assigned reason for seizing the vehicle.
