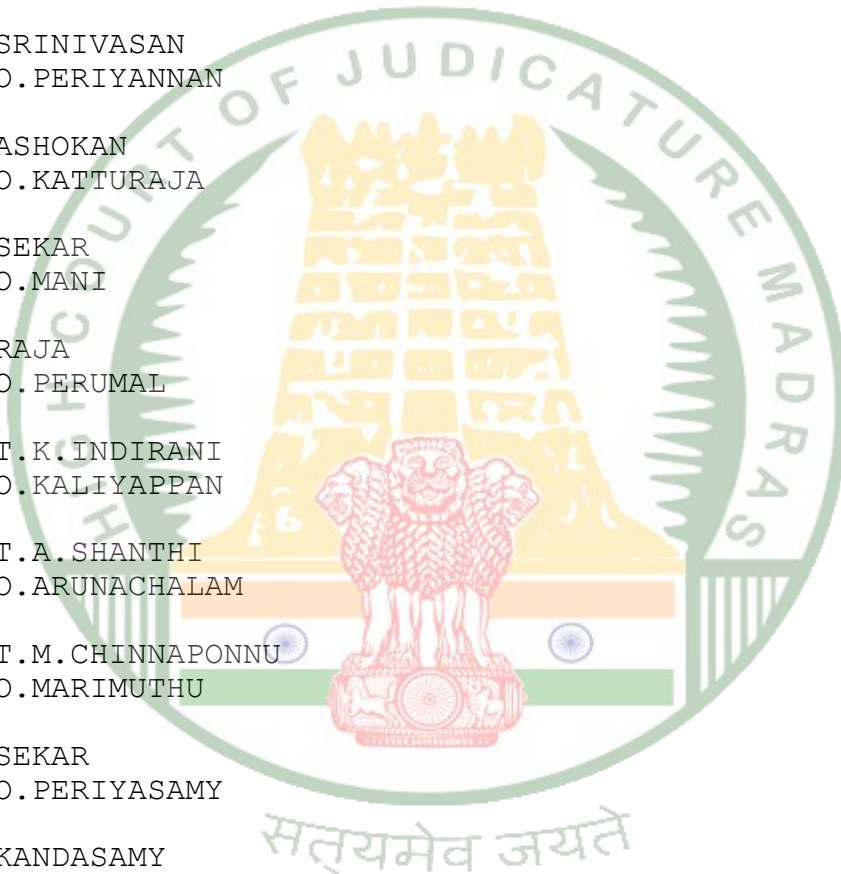

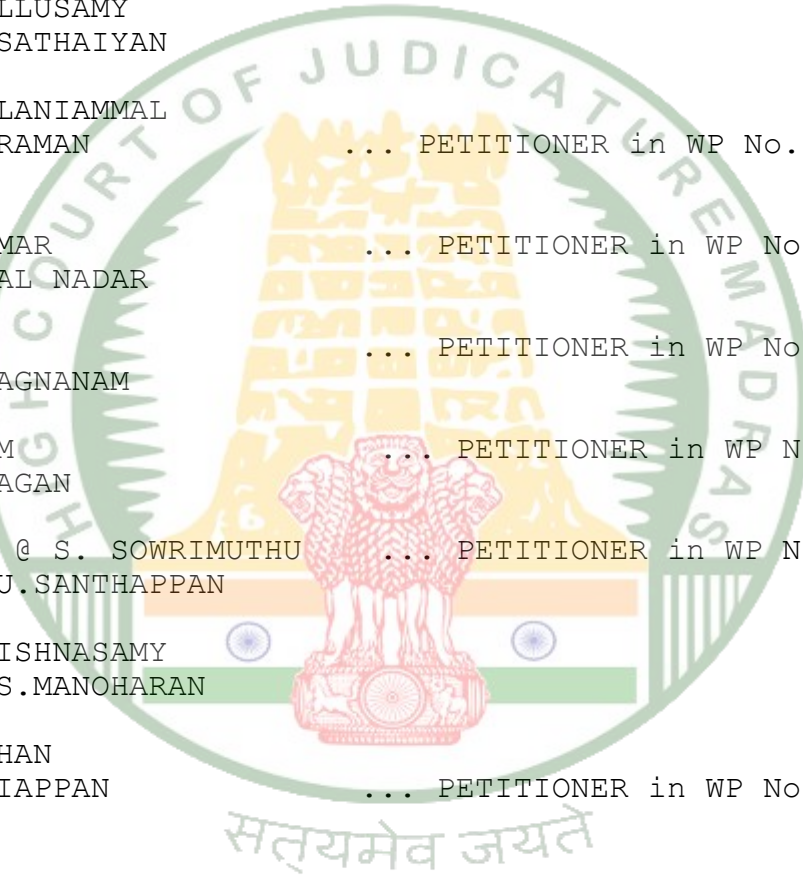

COMMON ORDER

(delivered by SATISH K. AGNIHOTRI, J.)

The petitioners in all these writ petitions primarily pray for bringing them into regular time scale from the date of completion of three years of service on consolidated pay basis.

2 Since the issue involved herein is one and the same, all these writ petitions are considered and decided by this common order.

3 The aforesaid issue involved in these writ petitions came up for consideration in a batch of writ appeals filed by the Government in The Secretary to Government of Tamil Nadu, Municipal Administration and Water Supply Department and two others - Vs. - M. Rani¹, which was partly allowed by a Division Bench of this Court, of which one of us was a Member (Satish K. Agnihotri, J.), vide common judgment dated 30th June 2015, observing as under:-

"29 Resultantly, for the reasoning and analysis made hereinabove, the appeals are partly allowed to the extent that the respondents are entitled to consideration for grant of time scale on regular basis on the basis of performance assessment to be done on

completion of three years and in the event, the performance of the respondents, is found satisfactory, they are entitled to regularisation on completion of three years, with all consequential monetary benefits. Costs made easy. Connected Miscellaneous Petitions are closed."

4 In view of the foregoing, these writ petitions also are disposed of in the same terms, in which, the aforesaid batch of writ appeals was decided. As a sequel, the petitioners are entitled to consideration for grant of time scale on regular basis on the basis of performance assessment to be done on completion of three years and in the event, the performance of the petitioners, is found satisfactory, they are entitled to regularisation on completion of three years, with all consequential monetary benefits. Costs made easy. Connected miscellaneous petitions are closed.

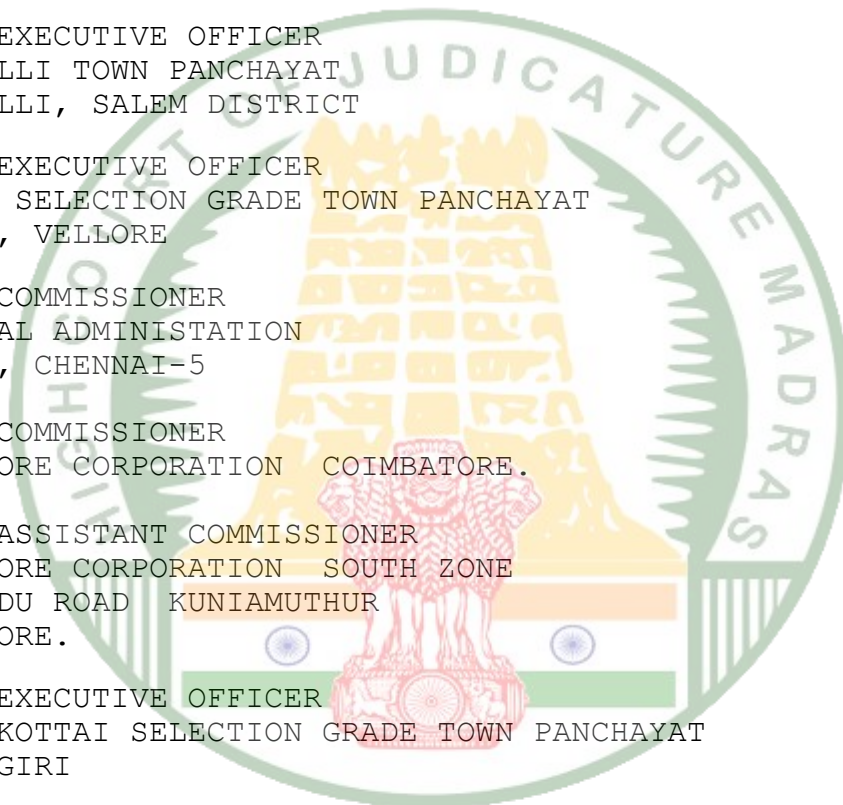
