The petitioners claiming to be the descendants of Marudhu Pandiyar Brothers of Sivaganga, made a request to the respondent seeking political pension. As the said representation has not been considered, the present Writ Petitions have been filed.

2.It is seen from the records that the petitioners' representations dated 03.12.2014 have indeed been received by the District Collector, Ramanathapuram District. He in turn, vide proceedings in Na.Ka.No.G2/ 64750/2014 dated 25.12.2014 directed the Tahsildar, Ramanathapuram to send a report and recommendations on the same. It appears that nothing has happened thereafter. This Court deems it fit to direct the District Collector, Ramanathapuram

to pass appropriate orders on the representation dated 03.12.2014 by considering the relevant materials within a period of eight weeks from the date of receipt of a copy of this order.

3.The Writ Petitions are disposed of accordingly. No costs.
