ORDER

(Order of the Court was made by SATISH K.AGNIHOTRI, J.)

The petitioners claiming to be the residents of the premises in question, which has been locked and sealed on 11.3.2015, by the Chennai Metropolitan Development Authority (CMDA), have made a joint representation dated 11.3.2015, to the Secretary to Government, Housing and Urban Development Department and also to the Member Secretary, CMDA, viz. the respondents 1 and 2 herein, for the purpose of de-sealing the premises occupied by them, so as to enable them to remove the office equipments, goods, stocks and all other fixtures lying therein and thereafter, the same may be re-sealed.

2.The learned Standing Counsel appearing for the CMDA, submits that the representation shall be considered and the premises shall be de-sealed granting one week time to the occupiers to remove the afore-stated articles and thereafter, after proper inspection, the same shall be re-sealed.

3. In view of the foregoing, we are not inclined to pass any other order except that the representation of the petitioners be considered by the authorities as afore-stated, for the purpose of removal of the articles. The writ petition stands disposed of. No costs.
