The only limited relief sought for in this writ petition is a direction to the official respondents to consider and take action on the representation dated 9.2.2015 of the petitioner and take

consequential action of removal of encroachment put up on the road.

2. Learned Government Advocate appearing for respondents 1 and 2 submits that on inspection and affording proper opportunity of hearing to the alleged encroachers, proper action would be taken for removal of the encroachment within a period of four weeks. Despite the service of notice on the 3rd respondent by the petitioner, there is no representation on behalf of the 3rd respondent.

3. In view of foregoing, the writ petition stands disposed of directing the 1st respondent to take necessary action as aforesaid within a period of four weeks from the date of receipt of copy of this order. No costs.
