3. Now, the country needs more toilets and temple. At this juncture, here is a person who is objecting for construction of public toilet. The Authorities who have proposed to put up public toilet would have considered all the pros and cons before construction of public toilet.

4. Admittedly, the petitioner is not the owner of the land and therefore, the petitioner lacks locus standi to object to the construction of toilet which is in public interest. Hence, the prayer sought for by the petitioner cannot be granted and this writ petition is dismissed. No costs. Consequently, the connected miscellaneous petition is closed.

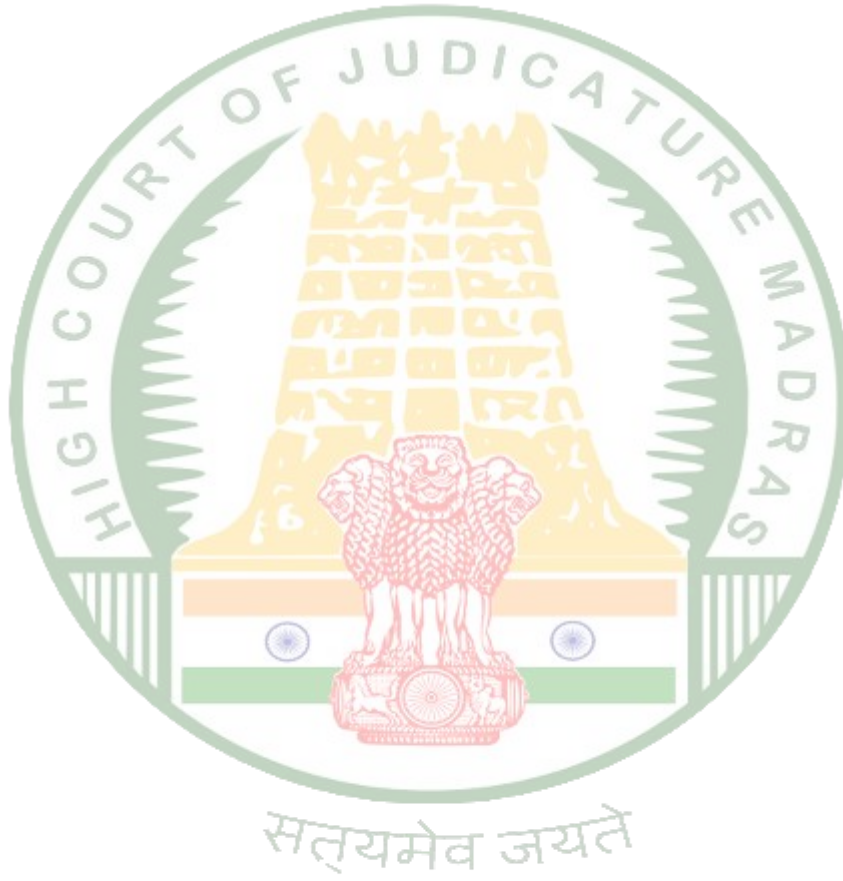
